ORDER

WHEREAS, the institution, namely, Arawali College of Advance Studies in Education, Plot No-164/21, 165/1, 10, 2, 12/1, 12/2, 12/3, 166/6/1, Ballabgarh Road, Vill-Pali, Faridabad, Haryana-121004 was granted recognition for B.Ed. course of two year duration with an annual intake of 100 seats vide NRC order No.F.NRC/NCTE/F-7/ dated 02.12.2006 and thereafter for another 100 seats vide Order No. NRC/NCTE/F-7/HR-772/2007/30971-30977 dated 19.10.2007 thereby making total annual intake of 200 seats followed by revised recognition order No.F.No./NRC/NCTE/HR-772/2015/111237-41 dated 05.06.2015 for conducting B.Ed. programme of two years duration with an annual intake of 200 seats, for four basic units of 50 seats each, from the academic session 2015-16.

AND WHEREAS, the institution submitted an affidavit on 02.11.2017 with a request to reduce the seats of B.Ed. Course from four basic units of 200 students to two basic units of 50 students each.

AND WHEREAS, the matter was placed before the NRC in its 277th meeting held from 05th to 06th December, 2017. The Committee considered the matter and decided that the request of the institution to reduce the number of seats from 4 units (200 students) to 2 units (100 students) to run B.Ed. course is accepted.

NOW THEREFORE, the Northern Regional Committee hereby reduces the number of seats of B.Ed. course from 4 units to 2 units of 50 students each of Arawali College of Advance Studies in Education, Plot No-164/21, 165/1, 10, 2, 12/1, 12/2, 12/3, 166/6/1, Ballabgarh Road, Vill-Pali, Faridabad, Haryana-121004.

ORDER

WHEREAS, in exercise of the powers conferred by sub-section (2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993) and in supersession of the National Council for Teacher Education (Recognition Norms and Procedure) Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. AND WHEREAS, the institution i.e. Aravali College Of Advanced Studies In Education, Ballabgarh Sohana Road, Vill- Pali, , Faridabad-121004 has been recognized for M.Ed course by NRC vide order No. F.NRC/NCTE/F-7/HR-783 dated 19 October 2007.

3. AND WHEREAS, the institution has by affidavit consented to come under New Regulations and has sought for one basic units in M.Ed., which require additional facilities.

4. AND WHEREAS, it has been decided to permit the institution to have one basic units of 50 students, subject to the institution fulfilling the following conditions, namely:-

- (i) The institution shall create additional facilities that include (a) additional built-up-area, (b) additional infrastructure, (c) additional funds, (d) adhere to staff norms as per Regulations, 2014 and inform Northern Regional Committee, with required documents by October 31, 2015.
- (ii) The institution for additional unit will be required to submit the required documents such as, land documents, non-encumbrance Certificate (EC), Land Use Certificate (LUC) and the Building Plan (BP) in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building completion Certificate (BCC) may be given along with other documents, if available, otherwise it can also be given to the Visiting Team at the time of inspection.
- (iii) The Regional Committee shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 February, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institution shall not be permitted to admit students for the academic year 2016-2017.
- (iv) In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/ Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith documents, if any, together with the documents referred above. In case the institution's request for shifting of premises is pending, such institution shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Northern Regional Committee in respect of Section 17/complaint cases etc.

5. Now therefore, in light of the above, the Northern Regional Committee, NCTE hereby issues the revised Recognition Order to i. Aravali College Of Advanced Studies In Education, Ballabgarh Sohana Road, Vill- Pali, , Faridabad-121004 for conducting M.Ed. programme of two years duration with an annual intake of 50 students, for one basic unit of 50 students, from the academic session 2015-2016 subject to fulfillment of the conditions mentioned herein before 31.10.2015.

6. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, State Government etc. as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as
